SPAEDA (Somerset Partnership Arts Education Agency) is seeking to recruit up to eight new Trustees to its governing body at an exciting and challenging time for arts education in schools – primary, secondary or tertiary, mainstream or special, state or privately funded.

The education sector is still undergoing change: the continued transfer to academy status for many institutions, the emergence of multi-academy trusts, changes in school funding and budget pressures. Alongside this has come a renewal in the recognition that children develop better in an environment and with a curriculum that include opportunities to participate in the arts, in its broadest sense.

SPAEDA's mission is to facilitate these opportunities with services targeted at schools, teachers and young people themselves. It is an arts education charity, with over 15 years' experience of providing training, advice, advocacy, resources and research in arts education. It has an embedded understanding of the arts and in-depth knowledge of schools and education and delivers artist led projects in response to schools' needs.

We are inviting applications from individuals who have a strong interest in how these two areas come together to provide exceptional opportunities for the development and well-being of children and young people. Applicants don't necessarily need to work in the arts or education sectors but in particular we are looking for people with experience of financial management, fundraising, marketing and communications, digital media, Legal affairs and charity and company governance.

The role of Trustee is non-executive, providing a rewarding opportunity to use your expertise and experience to help SPAEDA deliver its current programmes and develop its Strategic Plan for the period post 2019, when significant changes to education funding will impact on its business model.
